Re: Petition for redress of a personal grievance

In the spring of 2013 I was elected as the new RDA and I looked forward to building relationship with Gary, the RD, learning about the region and the RSCmembers. Unfortunately, Gary suffered a serious health crisis during the latter part of histerm forcing him to resign. I was elected to fill his term although a new RDA wasn't elected until 2014. During the remainder of this term I attended several workshops, a CAR workshop, the WSC and a zonal forum. I believe I indicated my difficulty with written reports, the RDA appeared willing to submitwritten reports and materials, which she did, in addition to my verbal reports. At no time during my term did any member of the RSC indicate to me that they expected and or wanted written reports from me. I believe that when a service body elects a trusted servant it becomes a commitment between them based on mutual respect and honest communication. In that regard it is the responsibility of the RSC body to make clear their expectations and to give their trusted servants the opportunity to meet those expectations. If members of the RSC were dissatisfied with my performance it should have been made known to me well before the General Assembly. After leaving the General Assembly I felt that members were left with the insinuation that I had not fulfilled my duties. Additionally, the nomination and election process as outlined in the regional

policy does not address the situation in which both myselfand Heidi were elected. That is, we were both elected to fulfill vacancies and not elected in theodd years as stated by regional policy. Since I did not consider my term a full duly elected term I believed that I could stand for nomination for a full term. Additionally I thought the election was conducted in a clumsy and confusing manner furthering the notion that not only was I not a nominee but that I had not fulfilled my duties based on misleading information expressed during the Q&A before the second balloting. In 30 plus years of NA service I have served in many positions and always left those positions feeling & believing that I had fulfilled the obligations entrusted to me. I don't feel good or satisfied with how my position with the region ended. I am asking the RSC to address my grievances in the following 2 areas of the regional policy:

1. Vacancies

There are only 2 brief and vague mention of vacancies. One is under Elections, the last paragraph states that vacant or unfilled positions can be filled on the floor of the RSC. And the second instance is in the RD & RDA section which states that either position, if vacated, can be filled by the RCMs at a regular RSC. There are no eligibility parameters for someone who has stepped in to a vacated position should they wish to stand for that position during a formal election process. And the election of a new RD rather arbitrarily states that only the RDA can be nominated and voted on for that position. It only becomes open should the candidate not receive a unanimous vote. Which brings us to the General Assembly.

2. General Assembly:

There are 2 items listed as cause for the assembly:issue discussion and RD & RDA elections. There are no parameters about how the meeting is to be conducted, who will conduct the meeting, who qualifies to vote, what constitutes a majority of voting members or recording of the voting. In fact the General Assembly has no guidelines whatsoever leaving it open to personal interpretation, confusion and possible discord.

This analysis occurs as the content is sent, received, and when it is stored. The TOS refers us to the privacy policy for further information. The privacy policy talks about how they respect the privacy you desire. They do say: We may combine personal information from one service with information, including personal information, from other Google services—for example to make it easier to share things with people you know. We will not combine DoubleClick cookie information with personally identifiable information unless we have your opt-in consent. Another words you can turn off the ability to have your ads modified or not allow them to share your information. Google offers these tools to let you set your preferences. These are not just your normal privacy preferences but also the identifying markers used for ads and such. Use these links to adjust your settings.

A Proposal for Consideration

Background information:

- 1. The Region policy requires that the Region shall send 20% of the operating capital, which is above and beyond the prudent reserves, to NAWS as a 7th Tradition Donation every quarter.
 - a. Serving as the Region Treasurer I do exactly this. I am glad to be allowed to be of service. It is a privilege and an honor. I try to serve as you would have me do.

The motion I want you to consider:

- 2. Rather than send the quarterly 7th Tradition donation to NAWS we can use that money to purchase literature from NAWS.
 - a. NAWS waives shipping and handling costs on orders \$500, and larger.
- 3. The Region Treasurer shall place the order, send the check, and receive the literature. The Treasurer shall bring the literature to the next RSC.
- a. The literature will be evenly divided between each Area of the Region. The RCM's will be responsible for taking the literature back to their respective Area. We CANNOT take any such action today. If this is tried one time as a test then the Region will need the tacit approval from

the Areas for us to not follow Region Policy. The RCM's must have time to take the matter back to the Areas. At the next RSC, in August, this item will appear under old business on the agenda. The Area's group consciences will be shared, and a Region group conscience will emerge.

Proposal from CTANA (Heidi M.):

To add the below sentence at the end of the 3rd paragraph under the heading Elections:

"Their term of office shall be for the remainder of the predecessor's term and conclude at the beginning of the next term."

And to add the following at the end of the paragraph regarding the RD Alternate:

"EXCEPTION: If the RDA was elected to fill an unexpected vacancy, BOTH RD positions will be open for nominations or volunteers at the next scheduled election."
